TERMS AND CONDITIONS - SPRING DEPOSIT BONUS PROMOTION

A. Introduction

- 1. XM Global Limited operating under the trading name XM is a Securities Service Provider Licensee regulated and authorised by the Financial Services Commission ("FSC") in Belize under the License Number 000261/309 (hereinafter called the "Company" or "XM").
- 2. The "Spring Deposit Bonus Promotion" (hereinafter the "Promotion") Terms and Conditions is an integral part of the "XM Business Terms and Policies" and provisions set herein are considered as an annex of all "XM Business Terms and Policies".

B. Conditions of Eligibility

- 1. Subject to, and without prejudice to, all other Business Terms and Policies, the offer is available to XM Clients who have satisfied the Eligibility Criteria for the "*Promotion*" ("*Eligible Clients*") as set out in the sections following hereinafter.
- 2. The "*Promotion*" is available **only** for existing and new clients residing in China, Taiwan, Hong Kong and Macau.
- 3. The "Promotion" is valid for the period 5th of April 2023 (09:30 AM Server Time) 28th of April 2023 (11:59 PM Server Time) ("Promotional Period").
- 4. Only persons who can form legally binding contracts under the laws applicable in their country of residence may participate in the "*Promotion*". Without limiting the foregoing, participation in the "*Promotion*" is not allowed for persons under the age of 18 or otherwise under legal age in their country of residence ("*minors*"). If you are a minor, you may not participate in the "*Promotion*".
- 5. Each participant agrees that by registering for the "Promotion" they express their free, prior and informed consent for the Company to process any personal data which they provide while registering. The data is collected and processed only to such extent, which is necessary to administer and run the "Promotion". The Company shall disclose any data about registrants only to the extent stipulated in these terms and conditions.  - a) family members, such as brothers, sisters, spouses, ancestors, lineal descendants and collateral descendants;
 - b) person or entity, whom any participant in the "*Promotion*", directly or indirectly,

through one or more intermediaries, controls, or whom, directly or indirectly, through one or more intermediaries, is controlled by, or is under common control with any participant in the "*Promotion*"; for purposes of this definition, the term "*control*" (including, with correlative meaning, the terms "*controlled by*" and "*under common control with*"), as used with respect to any participant in the "*Promotion*", shall mean the possession, directly or indirectly through one or more intermediaries, of the power to

- direct or cause the direction of management policies of such person or entity, whether through ownership of voting securities or otherwise.
- 8. Similarly, persons associated in any manner whatsoever with XM and/or with the specific websites and/or social network sites on which XM may be running from time to time certain specific promotions, contests and/or surveys, in the context of which access to the "*Promotion*" is offered, are not allowed to participate in the offer.

C. "Promotion" Terms

 All clients who meet the eligibility requirements set out in Section B.2 will be rewarded with 30% deposit bonus on their deposit(s) made during the "Promotional Period", provided that the maximum amount of any such deposit bonus awarded to any particular Eligible Client will be limited to a maximum amount of USD 1,000 (or currency equivalent).

D. Reservation of Rights and Disqualifications

XM reserves the right, at its reasonable discretion, to reject the participation of any Eligible Client to the "*Promotion*", if such Client engages in any prohibited trading activities, as described in XM's Terms and Conditions of Business, available at the following URL: https://www.xm.com/legal-documents.
- 2. XM reserves the right, at its sole discretion, to decline registration of any participant in the "Promotion" and further reserves the right to disqualify any participant in the "Promotion" who tampers or attempts to tamper with the operation of the "Promotion" or breaches these terms and/or any of the "XM Business Terms and Policies" set forth on XM's Website. Under no circumstances shall XM be liable for any consequences of any bonus cancelation or decline, including, but not limited to, order(s) closure by Stop Out.
- 3. Clients who provided incorrect or fraudulent details during the trading account registration will be disqualified from participating in the "*Promotion*".
