TERMS AND CONDITIONS - XM MANILA GRAND SEMINAR - ROUND 2

A. Introduction

1. XM Global Limited operating under the trading name XM is a Securities Service Provider Licensee regulated and authorised by the Financial Services Commission (“FSC”) in Belize (hereinafter called the “Company” or “XM”).
2. XM is offering its clients the opportunity to attend the **“XM Manila Grand Seminar - Round 2”** (the “Seminar”) that the Company is hosting in Manila, Philippines, given that the eligibility and other requirements set out herein are satisfied.

B. General Provisions

1. The Seminar will be hosted in Tagalog language on Saturday, **11th of November 2023**, as per the details below:
 - Seminar Time: 10:00 - 14:00 (PHT).
 - Location: “Diamond Hotel Philippines” Roxas Boulevard, Corner Dr. J. Quintos Street, Manila, 1000 Metro Manila, Philippines.
2. Registration for the Seminar is open for all clients of XM who reside in Philippines and who have, by the time of registration, at least one (1) verified XM real trading account with any base currency.
3. Clients must be older than 18 years old, shall already have a verified real account, registered with a valid email address, in order to be able to register and participate in the Seminar. The eligibility and participation requirements, set out herein, apply and must be met.
4. A maximum number of two hundred (200) Eligible Clients who have met the requirements set herein will be able to attend the Seminar.
5. Each client agrees that by registering for the Seminar they express their free, prior and informed consent for XM to process any personal data which they provide while registering. The data is collected and processed only to such extent, which is necessary to administer and run the Seminar. XM shall disclose any data about registrants only to the extent stipulated in these terms and conditions. Each registrant has the right to withdraw their consent for processing of personal data at any time. However, such a withdrawal may at the discretion of XM result in the disruption, suspension or termination of the client’s registration for participating in the Seminar.

C. Terms and Conditions and Eligibility

Attendance

1. Subject to sub-section B.2, all clients who have a verified real account with XM by the time of registration and have accepted the Seminar’s terms and conditions have the right to register and participate in the Seminar (the “Eligible Clients”).
2. Subject to the conditions set herein, Eligible Clients will be able to attend to the Seminar and receive an **“Avramis Ribbon Indicator”** provided that they have at least one verified real XM trading account by the **11th of November 2023**, have deposited as per Section D below and their registration has been confirmed as per Section C.3 below.

3. Registration alone does not reserve or guarantee Eligible Clients a seat in the Seminar. Only Eligible Clients whose registration has been confirmed by XM via email or telephone will have the chance to attend the Seminar.
4. Registration is open until the **11th of November 2023** before the event starts. XM reserves the right to close registration at the earliest date if no more seats are available.
5. One registration equates to one client, as the consideration is based on a 'per client' and not on a 'per account' basis. In the case where two or more clients use the same credentials XM reserves the right to reject the clients' registration form of the Eligible Clients who used the said same credentials.
6. By accepting the Seminar's terms and conditions, the participants agree and consent to taking photographs and making a video testimonial, as may be requested by XM. The participants agree that XM has the right to use the images resulting from the photography/video filming to only such extent as stipulated in these terms and conditions. The latter may include, but is not limited to, XM's right to use the above-mentioned material for publication purposes on XM's website and social media. Each Participant has the right to withdraw their consent for processing of personal data and the material mentioned above at any time. However, such a withdrawal may, at the reasonable discretion of XM, result in the removal of the winner's entitlement to the prizes.
7. All Eligible clients who will attend the seminar will enjoy a complimentary meal after the seminar.

D. Specific "Avramis Ribbon Indicators" Terms for all Eligible Clients

All the Participants who will make deposit(s) (multiple or single) of the minimum amount of USD 200 (or currency equivalent) in their XM real trading account during the "**Promotional Period**" will be eligible to receive the "**Avramis Ribbon Indicator Lite**" whereas, all the Participants who will make deposit(s) (multiple or single) of the minimum amount of USD 500 (or currency equivalent) in their XM real trading account during the "**Promotional Period**" will be eligible to receive the "**Avramis Ribbon Indicator Advance**". The Participants who will satisfy the above-mentioned deposit requirements and will be notified through the Company's official means of communication (e.g., email or phone call), in order to activate their Indicators. Please note that each Participant can receive **only one (1)** Indicator.

3. All Eligible Clients are permitted to only one registration per one (1) unique IP address. Multiple registrations from the same IP are not permitted nor multiple registration with same personal details. In such a case, XM reserves the right to immediately exclude such persons from participating in the Seminar.
