

# TERMS AND CONDITIONS HOW TO SUCCESSFULLY TRADE IN THE GOLD MARKET -SEMINAR 2023



## TERMS AND CONDITIONS - HOW TO SUCCESFULLY TRADE IN THE GOLD MARKET - SEMINAR 2023

### A. Introduction

- 1. XM Global Limited operating under the trading name XM is a Securities Service Provider Licensee regulated and authorised by the Financial Services Commission ("FSC") in Belize (hereinafter called the "Company" or "XM").
- XM is offering its clients the opportunity to attend the "*How to successfully trade in the gold market Seminar 2023*" (the "Seminar") that the Company is hosting in Bangkok, Thailand, given that the eligibility and other requirements set out herein are satisfied.

#### **B. General Provisions**

- 1. The Seminar will be hosted in Thai language on Saturday, 19th of August 2023, as per the details below:
  - Seminar Time: 09:00 -13:00 (GMT+7)
  - Location: "Bangkok Marriott Hotel Sukhumvit" 2 Sukhumvit Soi 57, Khlong Tan Nuea, Watthana, Bangkok 10110, Thailand.
- 2. Registration for the Seminar is open for all clients of XM residing in Thailand, who have, by the time of registration, at least one (1) verified XM real trading account with any base currency.
- 3. Clients must be older than 18 years old, shall already have a real account, registered with a valid email address, in order to be able to register and participate in the Seminar. The eligibility and participation requirements, set out herein, apply and must be met.
- 4. A maximum number of four hundred (400) Eligible Clients who have met the requirements set herein will be able to attend to the Seminar.
- 5. Each client agrees that by registering for the Seminar they express their free, prior and informed consent for XM to process any personal data which they provide while registering. The data is collected and processed only to such extent, which is necessary to administer and run the Seminar. XM shall disclose any data about registrants only to the extent stipulated in these terms and conditions. Each registrant has the right to withdraw their consent for processing of personal data at any time. However, such a withdrawal may at the discretion of XM result in the disruption, suspension or termination of the client's registration for participating in the Seminar.

#### C. Terms and Conditions and Eligibility

#### Attendance

- 1. Subject to sub-section B.2, all clients who have a real verified account with XM and have accepted the Seminar's terms and conditions have the right to register and participate in the Seminar (the "Eligible Clients").
- Subject to the conditions set herein, Eligible Clients will be able to attend to the Seminar and participate in the Lucky Draw that will place during the Seminar provided that they have at least one verified real XM trading account by the 18<sup>th</sup> of August 2023 and their registration has been confirmed as per Section C.3 below.



- 3. Registration alone does not reserve or guarantee Eligible Clients a seat in the Seminar. Only Eligible Clients whose registration has been confirmed by XM via email or telephone will have the chance to attend the Seminar.
- 4. Registration is open until the 18<sup>th</sup> of August 2023 at 11:59 PM (GMT+7) the latest. XM reserves the right to close registration at an earliest date if no more seats are available.
- 5. One registration equates to one client, as the consideration is based on a 'per client' and not on a 'per account' basis. In the case where two or more clients use the same credentials XM reserves the right to reject the clients' registration form of the Eligible Clients who used the said same credentials.
- 6. By accepting the Seminar's terms and conditions, the participants agree and consent to taking photographs and making a video testimonial, as may be requested by XM. The participants agree that XM has the right to use the images resulting from the photography/video filming to only such extent as stipulated in these terms and conditions. The latter may include, but is not limited to, XM's right to use the above-mentioned material for publication purposes on XM's website and social media. Each Participant has the right to withdraw their consent for processing of personal data and the material mentioned above at any time. However, such a withdrawal may, at the reasonable discretion of XM, result in the removal of the winner's entitlement to the prizes.

#### D. "Lucky Draw" Specific Terms for all Eligible Clients

- 1. Eligible Clients attending the Seminar (the "Participants") will have the opportunity to participate in the Lucky Draw which XM will conduct after the Seminar and win prizes in trading bonuses which will **not** be available for withdrawal.
- 2. The lucky draw winners will be chosen via a Lucky Draw, after the Seminar on 19<sup>th</sup> of August 2023 and will be announced the same day.
- 3. If the Eligible Client's trading account has been archived, the Company will request the winner to open a new one in order to receive the trading bonus or be able to activate his/her Indicator. Regarding the trading bonus prize, if the winner's real trading XM account is not eligible to receive trading bonuses then he/she will need to open a new account which is eligible to receive trading bonus in order to receive his/her prize.
- 4. In case the winners are unable to utilize the prize(s) and/or if any of the reasons of disqualification occurs, XM reserves the right to withdraw the prizes entitlement and award the prizes to an alternative winner on the Seminar day, with the same conditions applied and following the same procedure (i.e. Lucky Draw).

- 2. XM reserves the right to disqualify clients who provided incorrect or fraudulent details during the registration for the Seminar.
- 3. All Eligible Clients are permitted to only one registration per one (1) unique IP address. Multiple registrations from the same IP are not permitted nor multiple registration with same personal details. In such a case, XM reserves the right to immediately exclude such persons from participating in the Seminar.
- 4. XM reserves the right, at its sole discretion, to decline registration of any Eligible Client for the Seminar and further reserves the right to prohibit any Eligible Client, who breaches these terms and/or any of the "XM Business Terms and Policies" set forth on XM's website at the following URL: <u>https://www.xm.com/legal-documents</u>,from registering and/or participating in the Seminar.
