# TERMS AND CONDITIONS XM PHITSANULOK SEMINAR 2023



#### **TERMS AND CONDITIONS - XM PHITSANULOK SEMINAR 2023**

#### A. Introduction

- 1. XM Global Limited operating under the trading name XM is a Securities Service Provider Licensee regulated and authorised by the Financial Services Commission ("FSC") in Belize under the License Number 000261/309 (hereinafter called the "Company" or "XM").
- 2. XM is offering its clients the opportunity to attend the "XM Phitsanulok Seminar 2023" (the "Seminar") that the Company is hosting in Phitsanulok, Thailand, given that the eligibility and other requirements set out herein are satisfied.

#### **B.** General Provisions

- 2. Registration for the Seminar is open for all clients of XM who reside in Thailand and who have, by the time of registration, at least one (1) verified XM real trading account with any base currency.
