TERMS AND CONDITIONS - GLOBAL CASHBACK PROMOTION APRIL 2026

A. Introduction

1. XM Global Limited operating under the trading name XM is a Securities Service Provider Licensee regulated and authorised by the Financial Services Commission ("**FSC**") in Belize (hereinafter called the "**Company**" or "**XM**").
2. The "**Global Cashback Promotion April 2026**" (hereinafter the "**Promotion**") Terms and Conditions is an integral part of the "**XM Business Terms and Policies**" and provisions set herein are considered as an annex of all "**XM Business Terms and Policies**".

B. General Conditions of Eligibility

1. Subject to, and without prejudice to, all other Business Terms and Policies, the offer is available to XM Clients who have satisfied the Eligibility Criteria for the "**Promotion**" ("**Eligible Clients**") as set out in the sections following hereinafter.
2. The "**Promotion**" is available **only** for all active verified clients with an XM Standard or Micro real trading account from any jurisdiction that the Company is offering services.
3. The "**Promotion**" is valid for the period **7th of April 2026 - 7th of May 2026** ("**Promotional Period**").
4. Subject to Section B.2 above, the "**Promotion**" is available to all active verified clients with an XM Standard or Micro real trading account who during the "**Promotional Period**":

- have at least one (1) active verified XM Standard or Micro real trading account, with any base currency; **and**
- trade as per the table under section C.1. in order to generate cashback.

5. For the purposes of this "**Promotion**" eligible cashback lots are calculated based on the credit over equity ratio of your real trading account. Please see the example below as reference:

Credit over Equity Ratio Calculation: $Equity - Credit / Equity$

E.g. Balance: 1,000 USD, Credit: 100 USD, Equity: 1,100 USD = Ratio: 91%

1 Lot GOLD = 0.91 Eligible Cashback Lots.

6. Subject to Section B.4. and B.5. above, trading with bonus will not be considered as eligible trading. For example, a client deposits USD 100 in his/her XM real trading account and receives 100% bonus on the deposited amount (i.e. USD 100). The client opens a trade of standard lot of EUR / USD with leverage 500:1 and required margin USD 200. Since, USD 100 of the requested margin is bonus (i.e. 50% of USD 200), only the 0.5 lot of the client's trade is eligible for the "**Promotion**".
7. Only trades with a minimum difference of 20 pips between the opening and closing price are eligible for the "**Promotion**".
8. For the purposes of this "**Promotion**", clients that are also holders of an Investor Account and/or Strategy Manager Account can participate in the "**Promotion**" provided that they meet the eligibility and participation requirements as mentioned herein.
9. For the purposes of this "**Promotion**", any hedged orders will not qualify towards the required lot count.
10. Only persons who can form legally binding contracts under the laws applicable in their country of residence may participate in the "**Promotion**". Without limiting the foregoing, participation in the "**Promotion**" is not allowed for persons under the age of 18 or otherwise under legal age in their country of residence ("**minors**"). **If you are a minor, you may not participate in the "Promotion"**.



11. Each participant agrees that by registering for the "**Promotion**" they express their free, prior and informed consent for the Company to process any personal data which they provide while registering. The data is collected and processed only to such extent, which is necessary to administer and run the "**Promotion**". The Company shall disclose any data about registrants only to the extent stipulated in these terms and conditions. Each registrant has the right to withdraw their consent for processing of personal data at any time. However, such a withdrawal may at the reasonable discretion of the Company result in the disruption, suspension or termination of the participant's registration in the "**Promotion**".
12. The "**Promotion**" is permitted for the real accounts of a single client using a unique IP address. Multiple registrations of real accounts from the same IP address are not permitted.
13. Participation of "**Intermediaries/Related Parties**" in the "**Promotion**" is prohibited. If the registration and / or trading data of a participant in the "**Promotion**" corresponds with the registration and / or trading information, including but not limited to IP address, of another participant in the "**Promotion**", XM reserves the right to regard this matching as a reason for immediate disqualification. For the purposes hereof, the term "**Intermediary(ies)/Related Party(ies)**", when used in these Terms & Conditions, unless the context otherwise requires, shall mean to include any person or entity bearing a relationship with any participant in the "**Promotion**", including, without limitation:
 - a) family members, such as brothers, sisters, spouses, ancestors, lineal descendants and collateral descendants;
 - b) person or entity, whom any participant in the "**Promotion**", directly or indirectly,

through one or more intermediaries, controls, or whom, directly or indirectly, through one or more intermediaries, is controlled by, or is under common control with any participant in the "**Promotion**"; for purposes of this definition, the term "**control**" (including, with correlative meaning, the terms "**controlled by**" and "**under common control with**"), as used with respect to any participant in the "**Promotion**", shall mean the possession, directly or indirectly through one or more intermediaries, of the power to direct or cause the direction of management policies of such person or entity, whether through ownership of voting securities or otherwise.

14. Similarly, persons associated in any manner whatsoever with XM and/or with the specific websites and/or social network sites on which XM may be running from time to time certain specific promotions, contests and/or surveys, in the context of which access to the "**Promotion**" is offered, are not allowed to participate in the offer.

C. Specific "**Promotion**" Terms

1. Eligible Clients who meet the eligibility conditions set in Sections B.2, B.3 and B.4 above, as well as all the eligibility and participation requirements set herein, will be able to get the chance to win a prize from, as described in the table below.

2. Eligible Clients will be receiving one (1) ticket per each lot traded. In order to generate a ticket Eligible



Clients will need to trade at least three (3) standard round turn lots (or 300 micro round turn lots).

3. For example, and the purposes of this "**Promotion**" if an Eligible Client trades during the "**Promotional Period**" six (6) standard round turn lots (or 600 micro round turn lots) then he/she will receive the below cashback amount:

*(two (2) standard round turn lots (or 200 micro round turn lots) x USD 0) + (three (3) standard round turn lots (or 300 micro round turn lots) x USD 2 per lot traded) + (one (1) standard round turn lot (or 100 micro round turn lots) x USD 3 per lot traded) = USD 0 + USD 6 + USD 3 = **USD 9 Total amount of Cashback to be received.***

4. Additionally, for example, and the purposes of this "**Promotion**" if an Eligible Client trades during the "**Promotional Period**" twenty (20) standard round turn lots (or 2000 micro round turn lots) then he/she will receive the below cashback amount:

*(two (2) standard round turn lots (or 200 micro round turn lots) x USD 0) + (three (3) standard round turn lots (or 300 micro round turn lots) x USD 2 per lot traded) + (ten (10) standard round turn lots (or 1000 micro round turn lots) x USD 3 per lot traded) + (five (5) standard round turn lots (or 500 micro round turn lots) x USD 4 per lot traded) = USD 0 + USD 6 + USD 30 + USD 20 = **USD 56 Total amount of Cashback to be received.***

5. Eligible Clients will have the chance to enter the "**Promotion**" during the "**Promotional Period**". The latest date for entering the "**Promotion**" is the **7th of May 2026**.
6. The winners will be notified within one week after the end of the "**Promotional Period**".
7. By accepting the terms and conditions of the "**Promotion**", the winners who will win the prizes described in Section C.1 above agree and consent to taking photographs and making a testimonial, as may be requested by XM. The winners agree that XM has the right to use the images resulting from the photography/video filming to only such extent as stipulated in these terms and conditions. The latter may include, but is not limited to, XM's right to use the above-mentioned material for publication purposes on XM's website and social media. Each participant has the right to withdraw their consent for processing personal data and the material mentioned above at any time. However, such a withdrawal may, at the reasonable discretion of XM, result in the removal of the winner's entitlement to the prizes.

D. Reservation of Rights and Disqualifications

1. XM reserves the right, at its reasonable discretion, to reject the participation of any Eligible Client to the "**Promotion**", if such Client engages in any prohibited trading activities, as described in XM's Terms and Conditions of Business, available at the following URL: <https://www.xm.com/legal-documents>.
2. XM reserves the right, at its sole discretion, to decline registration of any participant in the "**Promotion**" and further reserves the right to disqualify any participant in the "**Promotion**" who tampers or attempts to tamper with the operation of the "**Promotion**" or breaches these terms and/or any of the "**XM Business Terms and Policies**" set forth on XM's Website. Under no circumstances shall XM be liable for any consequences of any bonus cancelation or decline, including, but not limited to, order(s) closure by Stop Out.
3. XM reserves the right, at its reasonable discretion, to amend and/or update the Terms and Conditions of the "**Promotion**", at any time, without any prior notice.
4. Clients who provided incorrect or fraudulent details during the trading account registration will be disqualified from participating in the "**Promotion**".
5. All Eligible Clients are permitted to only one registration per one (1) unique IP address. Multiple registrations from the same IP are not permitted nor multiple registration with same personal details. In such a case, XM reserves the right to immediately exclude such persons from participating in the "**Promotion**".
6. XM reserves the right, at its reasonable discretion, to decline participation of any Eligible Client to the "**Promotion**" and further reserves the right to prohibit any Eligible Client, who breaches these terms and/or



any of the "XM Business Terms and Policies" set forth on XM's website at the following URL: <https://www.xm.com/legal-documents>, from participating in the "*Promotion*" and claiming the won prize. In these circumstances, XM shall not be liable for any consequences of the participation cancelation.

7. Eligible Clients who have been disqualified lose their right to claim the prize offered.
8. Trading on BTCUSD, BTCEUR, BTCJPY or BTCGBP from Eligible Clients residing in the United Kingdom is excluded, thus their trading activity will only count for Gold, Silver, platinum or palladium.
9. If any of "*Promotion*" terms were to be translated into a language other than English, then the English version of these terms shall prevail where there is an inconsistency.
