TERMS AND CONDITIONS - XM GALA DINNER 2022

1. Introduction:

- 1.1. XM Global Limited operating under the trading name XM is a Securities Service Provider Licensee regulated and authorised by the Financial Services Commission ("FSC") in Belize under the License Number 000261/309 (hereinafter called the "Company" or "XM").
- 1.2. XM is offering its clients the opportunity to attend the "**XM Gala Dinner 2022**" (the "Seminar") (hereinafter called the "**Gala Dinner**") that the Company is hosting in Kuala Lumpur, Malaysia and participate to the Lucky Draw Raffle that will take place given that the eligibility and other requirements set out herein are satisfied.

2. General Provisions:

- 2.1. The "**Gala Dinner**") will be hosted on Saturday, 3rd of December 2022, as per the details below:
 - Gala Dinner Time: 17:00 - 22:30 (GMT +8)
 - Gala Dinner Location: MITEC, Kuala Lumpur
 - Gala Dinner Address: KL Metropolis, 8, Jalan Dutamas 2, Kompleks Kerajaan, 50480 Kuala Lumpur, Federal Territory of Kuala Lumpur, Malaysia.
- 2.2. The "**Gala Dinner**" is available only for clients residing in Malaysia and Brunei.
- 2.3. Subject to section 2.2 above, registration for the "**Gala Dinner**" is open to all existing and new clients of XM who at the time of registration, and until the 4th of November 2022 at the latest, have a validated XM trading account with any base currency and meet the eligibility requirements set out hereinafter.
- 2.4. Registration for the "**Gala Dinner**" can be achieved through the official website of XM or through the clients' Members Area.
- 2.5. Registration for the "**Gala Dinner**" is open until the 4th of November 2022 at 11:59 (GMT +8). XM reserves the right to close registration at an earliest date if no more seats are available.
- 2.6. Eligible clients may be qualified either for a Standard seat or a VIP seat to the "**Gala Dinner**" (please refer to section 3.2 and 3.3 below).
- 2.7. A maximum number of eight hundred (800) Eligible Clients who have met the eligibility requirements set herein will be able attend to the "**Gala Dinner**" and participate to the Lucky Draw raffle that will take place during the Gala Dinner.
- 2.8. Clients must be older than 18 years old and shall already have a validated real trading account registered with a valid email address, in order to be able to register and claim a seat in the "**Gala Dinner**". The eligibility and attendance requirements to claim a seat in the "**Gala Dinner**" set out herein, apply and must be met.
- 2.9. One registration equates to one client, as the consideration is based on a 'per client' and not on a 'per account' basis. In the case where two or more clients use the same credentials XM reserves the right to reject the registration form of the Eligible Clients who use the said same credentials.
- 2.10. Each client agrees that by registering for the "**Gala Dinner**" they express their free, prior and informed consent for the Company to process any personal data which they provide while registering. The data is collected and processed only to such extent, which is necessary to administer and run the "**Gala Dinner**". The Company shall disclose any data about registrants only to the extent stipulated in these terms and conditions. Each registrant has the right to withdraw their consent for processing of personal data at any time. However, such a withdrawal may at the reasonable discretion of the Company result in the disruption, suspension or termination of the client's registration for attending the "**Gala Dinner**".

3. Specific "Gala Dinner" Terms:

- 3.1. Eligible Clients who meet the registration requirements set out in sections 2.2. and 2.3. above, as well as all eligibility requirements set out herein, will be able to claim a seat for the "**Gala Dinner**".
- 3.2. Subject to section 3.1., eligible to claim a Standard seat to the "**Gala Dinner**" will be all existing and new clients who at the time of registration, and from 4th of October 2022 until 4th of November 2022:
 - have at least one (1) validated XM real trading account, with any base currency;
 - have a minimum amount of USD 400 (or currency equivalent) in their XM real trading account upon registration; and
 - trade at least three (3) standard round turn lots (or 300 micro round turn lots) on Forex, Gold or Silver.
- 3.3. Subject to section 3.1., eligible to claim a VIP seat to the "**Gala Dinner**" will be all existing and new clients who at the time of registration, and from 4th of October until 4th of November 2022:
 - have at least one (1) validated XM real trading account, with any base currency;
 - have a minimum amount of USD 400 (or currency equivalent) as balance in their XM real trading account upon registration; and
 - trade at least six (6) standard round turns lot (or 600 micro round turn lots) on Forex, Gold or Silver.
- 3.4. The attendees who will claim a VIP seat will have the opportunity for a double participation to the Lucky Draw Raffle and they will be seated within the VIP zone of the event, closer to the stage and the performance that will take place during the "**Gala Dinner**".
- 3.5. The seats will be available on a "first-come first-served" basis for the clients who meet the eligibility and requirements set herein.
- 3.6. Registration alone does not reserve or guarantee Eligible Clients a seat at the "**Gala Dinner**". Only Eligible Clients who meet the requirements mentioned herein above and whose registration has been confirmed by XM via telephone (i.e., two (2) confirmation calls) will have the chance to attend the "**Gala Dinner**" and enter the Lucky Draw Raffle for a chance to win any of the prizes as described in section 4.1.
- 3.7. Eligible Clients who will be attending to the "**Gala Dinner**" will receive their ticket via email which they will need to have with them in printed or electronic form and present it to the "**Gala Dinner**".

Each participant has the right to withdraw their consent for processing of personal data and the material mentioned above at any time. However, such a withdrawal may, at the reasonable discretion of XM, result in the removal of the winner’s entitlement to the prizes.

4.5. The Luck Draw Raffle is not open to XM’s employees or their relatives.

“Deposit Trading Bonus”:

4.6. The “**Promotion**” is valid for the period **4th October 2022 - 4th November 2022** (“**Promotional Period**”).

4.7. All clients who meet the eligibility requirements set out in Section B.2 will be rewarded with 100% deposit bonus on their next deposit(s) made during the “**Promotional Period**”, provided that the maximum amount of any such deposit(s) bonus awarded to any particular Eligible Client will be limited to a maximum amount of USD 500 (or currency equivalent).

- 5.2. Clients provided incorrect or fraudulent details during the registration for the “**Gala Dinner**”.
- 5.3. All Eligible Clients are permitted to only one registration per one (1) unique IP address. Multiple registrations from the same IP are not permitted nor multiple registration with same personal details. In such a case, XM reserves the right to immediately exclude such persons from attending the “**Gala Dinner**”.
- 5.4. XM reserves the right, at its sole discretion, to decline registration of any Eligible Client for the “**Gala Dinner**” and further reserves the right to prohibit any Eligible Client, who breaches these terms and/or any of the “XM Business Terms and Policies” set forth on XM’s website at the following URL: <https://www.xm.com/legal-documents>, from registering and/or participating in the “**Gala Dinner**”. In these circumstances, XM shall not be liable for any consequences of the registration and/or participation cancelation.
- 5.5. All Eligible Clients who attend the “**Gala Dinner**” are required at all times to maintain appropriate and respectful behavior. XM withholds the right to disqualify and escort any Eligible Client out of the “**Gala Dinner**” at any time, whenever it decides, in its sole discretion and without justification, if the said Eligible Client’s presence and behavior is disrespectful and not appropriate. The latter applies if the clients have not registered for attendance, or they have not been approved/confirmed.
- 5.6. The “**Deposit Bonus**” is not applicable for holders of XM Ultra Low and Shares trading account(s).
- 5.7. Eligible Clients who have been disqualified and escorted out of the “**Gala Dinner**” event lose their right to claim any prizes offered.
