## TERMS AND CONDITIONS - XM GALA DINNER 2023

### 1. Introduction

- 1.1. XM Global Limited operating under the trading name XM is a Securities Service Provider Licensee regulated and authorised by the Financial Services Commission (“FSC”) in Belize (hereinafter called the “Company” or “XM”).
- 1.2. XM is offering its clients the opportunity to attend the “**XM Gala Dinner 2023**” (hereinafter called the “**Gala Dinner**”) that the Company is hosting in Bangkok, Thailand given that the eligibility and other requirements set out herein are satisfied.

### 2. General Provisions:

- 2.1. The “**Gala Dinner**” will be hosted on Saturday, 28<sup>th</sup> of October 2023, as per the details below:
  - Gala Dinner Time: 16:00 - 23:00 (GMT+7)
  - Gala Dinner Location: Centara Grand & Bangkok Convention Centre at CentralWorld
  - Gala Dinner Address: 999, 99 Rama I Rd, Khwaeng Pathum Wan, Khet Pathum Wan, Krung Thep Maha Nakhon 10330
- 2.2. The “**Gala Dinner**” is available only for clients residing in Thailand and Laos.
- 2.3. Subject to section 2.2 above, registration for the “**Gala Dinner**” is open to all existing and new clients of XM who at the time of registration, and until the 21<sup>st</sup> of October 2023 at the latest have at least one (1) verified XM trading account with any base currency and meet the eligibility requirements set out hereinafter.
- 2.4. Registration for the “**Gala Dinner**” can be achieved through the official website of XM or through the clients’ Members Area.
- 2.5. Registration for the “**Gala Dinner**” is open from the 21<sup>st</sup> of September until the 21<sup>st</sup> of October 2023 at 11:59 pm (server time). XM reserves the right to close registration at an earliest date if no more seats are available.
- 2.6. A maximum number of seven hundred (700) Eligible Clients who have met the eligibility requirements set herein will be able attend to the “**Gala Dinner**”.
- 2.7. Clients must be older than 18 years old and shall already have a verified real trading account registered with a valid email address, in order to be able to register and claim a seat in the “**Gala Dinner**”. The eligibility and attendance requirements to claim a seat in the “**Gala Dinner**” set out herein, apply and must be met.
- 2.8. One registration equates to one client, as the consideration is based on a ‘per client’ and not on a ‘per account’ basis. In the case where two or more clients use the same credentials XM reserves the right to reject the registration form of the Eligible Clients who use the said same credentials.
- 2.9. Each client agrees that by registering for the “**Gala Dinner**” they express their free, prior and informed consent for the Company to process any personal data which they provide while registering. The data is collected and processed only to such extent, which is necessary to administer and run the “**Gala Dinner**”. The Company shall disclose any data about registrants only to the extent stipulated in these terms and conditions. Each registrant has the right to withdraw their consent for processing of personal data at any time. However, such a withdrawal may at the reasonable discretion of the Company result in the disruption, suspension or termination of the client’s registration for attending the “**Gala Dinner**”.
- 2.10. By accepting the Event’s terms and conditions, the participants acknowledge the Risk Disclosure available on XM’s website.

### 3. Specific “Gala Dinner” Terms:

- 3.1. Eligible Clients who meet the registration requirements set out in sections 2.2. and 2.3. above, as well as all eligibility requirements set out herein, will be able to claim a seat for the “**Gala Dinner**”.
- 3.2. Subject to section 3.1., eligible to win a Double Gift Token and receive two (2) Lucky Draw tickets for the Lucky Draw that will take place during the “**Gala Dinner**” will be all existing and new clients who at the time of registration, and from 21<sup>st</sup> of September 2023 until 21<sup>st</sup> of October 2023:
  - have at least one (1) verified XM real trading account, with any base currency;
  - have a minimum amount of USD 300 (or currency equivalent) as balance in their XM real trading account upon registration;
  - trade at least twenty (20) standard round turn lots (or 2000 micro round turn lots) on Forex, Gold or Silver; and
  - Attend the “**Gala Dinner**”.
- 3.3. Subject to section 3.1., eligible to win a Single Gift Token and receive one (1) Lucky Draw ticket for the Lucky Draw that will take place during the “**Gala Dinner**” will be all existing and new clients who at the time of registration, and from 21<sup>st</sup> of September 2023 until 21<sup>st</sup> of October 2023:
  - have at least one (1) verified XM real trading account, with any base currency;
  - have a minimum amount of USD 300 (or currency equivalent) as balance in their XM real trading account upon registration;
  - trade at least ten (10) standard round turn lots (or 1000 micro round turn lots) on Forex, Gold or Silver; and
  - Attend the “**Gala Dinner**”.
- 3.4. All seats will be available on a “first-come first-served” basis for the clients who meet the eligibility and requirements set herein.
- 3.5. Registration alone does not reserve or guarantee Eligible Clients a seat at the “**Gala Dinner**”. Only Eligible Clients who meet the requirements mentioned herein above and whose registration has been confirmed by XM via telephone (i.e., two (2) confirmation calls) will have the chance to attend the “**Gala Dinner**”.
- 3.6. Eligible Clients who will be attending to the “**Gala Dinner**” will receive their ticket via email which they will need to have with them in printed or electronic form and present it at the entrance of the “**Gala Dinner**”.
- 3.7. Eligible Clients who will be attending the “**Gala Dinner**” will enjoy music, live performances, and many more.
- 3.8. Eligible Clients who will be attending the “**Gala Dinner**” who meet the requirements mentioned herein above, will need to register at the “**Gala Dinner**” at 16:00 (GMT+7).

Each Eligible Client has the right to withdraw their consent for processing of personal data and the material mentioned above at any time. However, such a withdrawal may, at the reasonable discretion of XM, result in the removal of the winner’s entitlement to the prizes.

4.7. The Lucky Draw is not open to XM’s employees or their relatives.

## 5. Reservation of Rights and Disqualifications:

5.1. XM reserves the right to reject any registration form if Eligible Clients engage in any prohibited trading activities, as described in XM’s Terms and Conditions of Business, available at the following URL: <https://www.xm.com/legal-documents>.

5.2. Clients provided incorrect or fraudulent details during the registration for the “**Gala Dinner**” will be disqualified from participating to the “**Gala Dinner**”.

5.3. All Eligible Clients are permitted to only one registration per one (1) unique IP address. Multiple registrations from the same IP are not permitted nor multiple registration with same personal details. In such a case, XM reserves the right to immediately exclude such persons from attending the “**Gala Dinner**”.

5.4. XM reserves the right, at its sole discretion, to decline registration of any Eligible Client for the “**Gala Dinner**” and further reserves the right to prohibit any Eligible Client, who breaches these terms and/or any of the “XM Business Terms and Policies” set forth on XM’s website at the following URL: <https://www.xm.com/legal-documents>, from registering and/or participating in the “**Gala Dinner**”. In these circumstances, XM shall not be liable for any consequences of the registration and/or participation cancellation.

5.5. All Eligible Clients who attend the “**Gala Dinner**” are required at all times to maintain appropriate and respectful behavior. XM withholds the right to disqualify and escort any Eligible Client out of the “**Gala Dinner**” at any time, whenever it decides, in its sole discretion and without justification, if the said Eligible Client’s presence and behavior is disrespectful and not appropriate. The latter applies if the clients have not registered for attendance, or they have not been approved/confirmed.

5.6. Eligible Clients who have been disqualified and escorted out of the “**Gala Dinner**” event lose their right to claim any prizes offered.
